Code of Conduct

The YMCA is committed to providing a safe and welcoming environment for everyone. All individuals are expected to act appropriately at all times in our facility, on our property or participating in our programs/activities and to adhere to the values of the YMCA – caring, honesty, respect and responsibility. Individuals should immediately notify a staff member of behavior which threatens their safety or comfort or that of someone else.

Prohibited actions include, but are not limited to:

- Inappropriate, immodest, or sexually revealing attire.
- Angry or vulgar language, including swearing, name-calling or shouting.
- Physical contact with another person in any angry or threatening way.
- Any demonstration of sexual activity or sexual contact with another person.
- Harassment or intimidation by words, gestures, body language or any menacing behavior.
- Theft or behavior that results in the destruction of property.
- Carrying or concealing any weapons or devices or objects that may be used as weapons.
- Using or possessing illegal narcotics or alcohol on YMCA property, in YMCA vehicles, or at YMCA sponsored programs/activities.
- Refusal to verify identity when asked by YMCA staff.
- Loitering within or on the grounds of the YMCA.
- Smoking in our facilities or on our property – the YMCA and its property is a smoke-free environment.

The YMCA reserves the right to deny access to the facility or grounds and/or to provide membership privileges to any person who has been accused or convicted of any crime involving sexual abuse, is a registered sex offender, has ever been convicted of any offense relating to the use, sale, possession, or transportation of narcotics or habit forming and/or dangerous drugs, is under the influence (whether currently or habitually) of narcotics, chemicals, intoxicating beverages and/or habit forming or dangerous drugs, or whose behavior does not conform to this Code of Conduct.

Suspension or termination of current YMCA membership, guest privileges or program participation may result from a violation of the Code of Conduct. This Code of Conduct is subject to modification at the discretion of the YMCA.

Informed Consent

Members, guests and program participants agree that participation in all programs and services is purely voluntary and shall be undertaken at the member's, guest's or program participant's sole risk, and the YMCA, its servants, agents or employees shall not be liable for, and are hereby released from any claim, demand, actions, or causes of action and related expenses including attorney's fees whatsoever for injuries, illnesses or damages to any person or property arising out of or in connection with the use of the services and facilities of the YMCA or the premises where the same are located.

Members, guests and program participants understand that it is strongly recommended that they have a physical examination by their physician before beginning any physical fitness program.

Members, guests and program participants give permission to the YMCA to use, without limitation or obligations, photographs, film footage, or tape recordings which may include member's, guest's or program participant's image or voice for purposes of promoting or interpreting YMCA programs.
